IFL Membership rights and responsibilities per constitution

ARTICLE I: MEMBERSHIPS:

1.01 Regular Members:

A regular member will be:

- a. Muslim.
- b. At least eighteen (18) years of age.
- c. Files an application with the required dues, as may from time to time be set by the Board of Trustees.
- d. Agrees to abide by the Articles of Incorporation and Bylaws of IFL.

All applications are subject to the approval of the Board of Trustees. Each member will be entitled to one vote in all matters coming before General Assembly meetings.

Regular Members will be hereinafter referred to as Members. Regular Members will have the right to vote in IFL elections and will elect Trustees and Officers of IFL.

1.02 Privileges:

A regular member will have the following privileges:

- a. One vote in IF election and general or special assembly meetings.
- b. Hold offices of the Executive Committee, and those of the Board of Trustees.
- c. Reduced fee for services provided by the IFL, include but not limited to school, tuition, graves and attending event sponsored by the IFL.

1.05 Termination of Membership:

A membership may be automatically terminated and final by the Board if:

- a. A member disagrees to abide by the Articles of Incorporation and Bylaws of IFL.
- b. A member has been convicted in a US court of law of a felony crime that includes, but is not limited to, moral turpitude shall be subject to admonishment, censure, suspension or expulsion from this organization by Board action which is final.

1.06 Appeal:

Any Member whose membership was revoked may arbitrate the matter, in accordance with the provisions of these Bylaws.

1.07 Membership dues and Fee:

The Board of Trustees reserves the right to periodically review and modify the membership dues of the Islamic Foundation of Lincoln (IFL). For a family membership, the dues will be set at an amount less than double that of an individual membership. In this context, a family membership is defined as comprising a husband and wife. Each individual member shall possess one voting right, while family members will be entitled to a maximum of two votes.

Furthermore, the Board has the authority to grant regular voting membership to other adult individuals residing with the family, provided they pay dues at a substantially reduced rate compared to single members.

Annual dues shall be payable on the first day of each calendar year, and the corresponding payment must be submitted along with the membership application. It should be noted that honorary and associate members are exempt from any dues obligation.

In addition, the Board, upon the General Assembly's approval, retains the ability to impose additional charges and fees for specific purposes, such as establishing or maintaining a building fund. The Board also reserves the right to establish charges or fees for special events and activities as it deems appropriate.

Extract of Article 2.01:

Only members who are current with their annual dues shall be entitled to vote at any meeting. Each member who has maintained good standing for the immediately preceding sixty (60) days will have one vote.
